Born and raised in Las Vegas, Nevada, Kristen's journey into architecture began at Northwest Career and Technical Academy, where she specialized in Engineering and Design. Her early exposure to CAD, Revit, and SolidWorks, along with interdisciplinary studies in architecture, civil, and structural engineering, laid the foundation for a career in architecture.

Kristen earned her Bachelor of Arts in Architecture from the Academy of Art University in San Francisco in 2018, where she was an active member of AIAS and couldn't get enough of the academic and professional community in San Francisco. She later returned to Las Vegas to pursue her Master of Architecture at UNLV, graduating in 2020 while balancing full-time work at PGAL with graduate studies. Her dedication was recognized through the NEWH Las Vegas Chapter scholarships in 2019 and 2020, totaling \$10,000, awarded for her leadership and contributions to hospitality design through the Hospitality Design studio as part of her thesis on, "Addressing Problem Gaming through the Built Environment". As a student member of NEWH, she participated in community-driven events such as Glamping at Zion Ponderosa Ranch, where her team's "Burning Glam Structure" won the largest burn category, an effort that raised scholarship funds and fostered creative collaboration between design students and mentors.

Kristen's licensure journey began in 2020, immediately following her graduation from UNLV and during the height of the COVID-19 pandemic—a time that disrupted traditional study methods and isolated candidates from peer support. Navigating the Architect Registration Exams (AREs) under these conditions required exceptional discipline, adaptability, and perseverance. Recognizing the challenges of the process, Kristen became deeply committed to helping others through it, offering guidance and encouragement to emerging professionals.

A key factor in her success was the mentorship she received, both within her firm and from outside professionals who generously shared their experiences, strategies, and support. Within her current firm, Kristen benefited from a culture of support and shared learning, while external mentors helped her navigate the broader licensure landscape. Through Kristen's leadership as Emerging Professionals Director, she is cultivating a thriving pipeline of future architects across Northern Nevada.




3.2 NEXT. Committee Chair





Together with her team, Kristen helped reimagine YODENG as NEXT., a fresh, inclusive brand celebrating the future of design in Northern Nevada.




4.2 CANstruction 2025

In 2025, JKAE partnered with Sierra Nevada Job Corps to create “Sisters in the Brotherhood” for AIA Northern Nevada’s CANstruction competition. The structure depicts a woman proudly standing in a pink safety vest and hard hat, built entirely from canned goods to symbolize the strength, skill, and resilience of women in construction. The bold letters “SIB” represent Sisters in the Brotherhood, a nod to unity, mentorship, and support within the trades community.

Kristen played a key role in conceptualizing and coordinating the design, helping bridge the collaboration between JKAE and Job Corps. Her involvement exemplified her passion for mentorship, teamwork, and community service, values that align with the core mission of AIA Northern Nevada.

This impactful installation honored the hard-working women breaking barriers and building a better future, both on job sites and in their communities. Beyond its symbolic power, the structure reinforced CANstruction’s mission to Fight Hunger, with all canned goods donated to the Food Bank of Northern Nevada, helping to support families and communities across the region.

Through Kristen’s leadership and collaboration with Job Corps, the “Sisters in the Brotherhood” build stood as both a celebration of women in the trades and a beacon of community impact.

4.5 Network of Executive Women in Hospitality



PROJECT DESCRIPTION

The AES Building represents a significant step forward in the College of Engineering's efforts to achieve "top-tier" status by combining active student learning environments with cutting-edge professional research laboratories. AES supports the college's mission: to Educate, Engage, Innovate, and Inspire. Programming goals include creating a campus building integrated into the network of engineering facilities, using the building as a recruitment tool, and showcasing engineering programs through hands-on, innovative learning environments that foster interaction among students, professors, and researchers.


AES is a three-story, 50,000-square-foot facility connected at the second floor to the third level of the Thomas Beam A building, promoting shared use of existing amenities. The first floor features a large makerspace and active learning classroom on the southern half, fronting the university mall. A flexible auditorium, divisible classroom, and lobby occupy the northern half, with building support spaces in the northeast corner.

Due to site slope, the first floor is elevated slightly above the mall. A shaded exterior patio adjacent to the auditorium and makerspace helps resolve grade differences and serves as an amenity for student and private events.

The west bay and bridge connector of the second floor are programmed for faculty, post-doc, and graduate student offices. The center bay is designated for enclosed laboratory support space, while the eastern bay remains an open, flexible lab with movable benches and desk space. The third floor mirrors the second, with the key difference being its wet lab design. Fume hoods and sinks are located in the center bay and along the west wall of the open lab to support flexible bench arrangements without fixed utility connections.

PROJECT DESCRIPTION


With almost 1,000 employees and volunteers, the Clark County Fire Department is the largest in Nevada. Its stations are strategically located to minimize response times and support fire suppression, emergency medical services (EMS), training, and administrative functions. The department's mission is to "provide optimum protection and prevention for our residents and visitors, with the highest level of valor, integrity, commitment, teamwork, and community involvement."

The design of the new prototype fire station builds on lessons learned from previous Clark County facilities, best practices observed at other stations, and input from design charrettes and departmental stakeholders. The resulting design is simple, efficient, and aligned with the Fire Department's goal of maintaining a modest, functional image.

Core functions include fire suppression, EMS, training, and vehicle housing for apparatus such as engines, ladder and rescue trucks, mobile air units, and hazardous materials vehicles. Programmed spaces are organized into apparatus, equipment, administration, training, living, and ancillary zones, ensuring the facility supports the full range of fire department operations.


PROJECT DESCRIPTION

The Moana Springs Community Aquatic & Fitness Center is a transformative civic project redefining recreation in Reno, Nevada. Commissioned by the City of Reno, this \$52 million facility delivers a vibrant destination for health, wellness, and community connection.

The Aquatic & Fitness Center brings together state-of-the-art aquatic amenities, modern fitness spaces, and welcoming public areas under one dynamic roof. The architecture celebrates transparency and movement using daylight, glass, and open sightlines to blur the boundaries between indoors and outdoors, fitness and leisure, individual and community.

Delivered through the Construction Manager at Risk (CMAR) method, the project fostered collaboration and innovation from concept through completion. Early engagement between the design and construction teams streamlined coordination, optimized costs, and preserved design integrity through every phase.

Completed in September 2024, the Moana Springs Community Aquatic & Fitness Center stands as a model for how thoughtful design and proactive delivery can create lasting civic value energizing the heart of Reno and inspiring the community it serves.


